We are pleased to report the payment of the Advent Claymore Convertible Securities and Income Fund II's (the "Fund") monthly distribution in the amount of \$0.0470 per share payable on February 28, 2018 to shareholders of record on February 15, 2018. The Fund currently anticipates that \$0.0126 per share, or 26.81% of this distribution would currently be classified as income, \$0.0261 per share, or 55.53% of this distribution would currently be classified as short-term capital gain and \$0.0083 per share, or 17.66% of this distribution would currently be classified as a return of capital. A final determination of the tax character of distributions paid by the Fund in 2018 will be reported to shareholders in January 2019 on Form 1099-DIV.
