We are pleased to report the payment of the Advent Claymore Convertible Securities and Income Fund II's (the "Fund") monthly distribution in the amount of \$0.0470 per share payable on December 29, 2017 to shareholders of record on December 15, 2017. The Fund currently anticipates that \$0.0136 per share, or 28.94% of this distribution would currently be classified as income, \$0.0161 per share, or 34.25% of this distribution would currently be classified as short-term capital gain and \$0.0173 per share, or 36.81% of this distribution would currently be classified as a return of capital. A final determination of the tax character of distributions paid by the Fund in 2017 will be reported to shareholders in January 2018 on Form 1099-DIV.
