Guggenheim Credit Income Fund 2019 ("GCIF 2019"), formerly known as Guggenheim Credit Income Fund – I, has paid distributions to shareholders during the quarter ended March 31, 2018. This notice is provided pursuant to Section 19(a) of the Investment Company Act of 1940 and Rule 19(a) thereunder, which provide that any distribution in the nature of a dividend payment not made solely from net investment income and accumulated undistributed net income must be accompanied by a written statement adequately disclosing the sources of such distribution payment.

In accordance with generally accepted accounting principles ("GAAP") the following table discloses the estimated sources of the distributions declared for the first quarter of 2018.

GCIF 2019 will mail a Form 1099-DIV to shareholders in February 2019 that will report the allocation components of calendar year distributions for federal income tax reporting purposes.
