# Carey Credit Income Fund Announces Change in Feeder Funds' Offering Prices

NEW YORK, September 14, 2016 -- W. P. Carey Inc. and Guggenheim Partners, LLC announced today that Carey Credit Income Fund 2016 T (CCIF 2016 T) and Carey Credit Income Fund – I (CCIF – I) adjusted their public offering prices from \$9.70 per share to \$9.75 per share and \$26.15 per share to \$26.30 per share, respectively. The adjustments were made due to an increase in CCIF 2016 T's and CCIF – I's net asset value (NAV) per share, which were \$9.17 and \$25.38, respectively, as of September 12, 2016. These increases in the public offering prices will be effective as of the CCIF 2016 T's and CCIF – I's September 15, 2016 weekly closing and will be first applied to subscriptions received from September 7, 2016 through September 13, 2016. These increases in public offering prices ensure that the NAV of each offering does not exceed the net offering price of the respective offering.
