Guggenheim Credit Income Fund 2019 ("GCIF 2019") has paid distributions to shareholders during the quarter ended December 31, 2018. In accordance with generally accepted accounting principles ("GAAP") the following table discloses the estimated sources of the distributions declared for the fourth quarter of 2018.

The timing and character of distributions for federal income tax purposes are determined in accordance with income tax regulations which may differ from GAAP. As such, all or a portion of this distribution may be reportable as taxable income. GCIF 2019 will mail a Form 1099-DIV to shareholders in February 2019 that will report the allocation components of calendar year distributions for federal income tax reporting purposes.
