The Total Income Portfolio, Series 26 (Trust) seeks to provide current income and, as a secondary objective, the potential for capital appreciation.

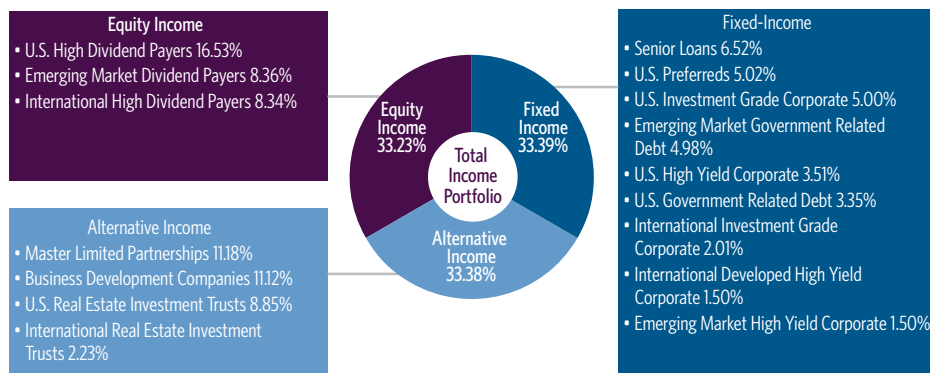

liquidity of those investments. If a BDC is required to liquidate all or a portion of its portfolio quickly, it may realize significantly less than the value at which such investments are recorded. BDCs frequently have high expenses, including the payment of management fees, administration expenses, taxes, interest payable on debt, governmental charges, independent director fees and expenses, valuation expenses, and fees payable to third parties relating to or associated with making investments.
